- **Department & Major** : 6 majors in 3 departments (Department of Investigation, Department of Criminology and Department of Public Safety)

- **Eligibility** : Foreigners(Both applicant and parents should be foreign nationals), or applicants with full educational background outside of the Republic of Korea
- **Tuition** : Fully exempted
 - ※ In each semester, the graduate school committee will determine whether to pay for a student's tuition for the next semester after deliberation considering the required credits(six credits per semester), etc
 - ※ If a student fails to graduate within the duration of a program period, he or she will have to pay tuition for the remaining period
- **Financial Aid** : Livelihood support(food/daily necessities), books, etc
 - ※ Provisions are made during the program, and support will be ceased immediately in case of drop outs and expulsion. Support may be ceased seized due to internal/external circumstances
- **Period required for completing the course** : 3 years for doctorate degree course and 2 years for master's degree course

04 Screening Methods

- **Screening method** : successful candidates are selected after 1st phase of document screening and 2nd phase of online video interview

Phase 1	Document Screening (100 points)	<ul style="list-style-type: none"> ▶ Qualification and academic ability evaluated based on submitted documents ▶ 3 times of admission quota selected in the order of scores from document screening
Phase 2	In-depth Interview (100 points)	<ul style="list-style-type: none"> ▶ Online video interview with candidates selected from the screening conducted to evaluate the applicant's knowledge of the field, academic ability and contribution potential <ul style="list-style-type: none"> ※ Less than 60 points will be deemed disqualified ▶ The format of the interview may be changed to phone interview(applicant/recommender/parent) depending on the circumstances of the university school
Final Selection	Total score from phase 1 & 2 (200 points)	<ul style="list-style-type: none"> ▶ Successful candidates will be selected based on combined scores from the screening and interview.

※ Detailed screening methods such as evaluation items shall be determined by the graduate school committee

- After an open recruitment for foreign nationals whose parents are also foreigners and those who completed their full education outside of Korea, the selection of successful candidates will be made through 1st phase of document screening and 2nd phase of interview
- Three times of admission quota will be selected from document screening, and those who pass document screening will be given an interview
- Among applicants who receive scores greater than 60 points in the interview, successful candidates will be selected based on combined scores from the document screening and interview in the order of the highest scores

- **Evaluation Items**

05 Screening Procedures

A. Application: Monday, June 8, 2020, 09:00 ~ Tuesday, June 30, 2020, 23:00

- 1) Sign up on the application website “Jinhaksa”(http://www.jinhakapply.com) and access the application window
 - ※ Accessible via “Go to Application Website(banner)” on the Korean National Police University website(http://www.police.ac.kr)
- 2) Fill out a form as indicated [upload a photo(3cm x 4cm) taken within 3 months] and pay the application fee
- 3) Complete the application(complete the application fee payment) and print out the confirmation form
 - ※ As the website may be overwhelmed with applicants on the last day of application, applicants are recommended to complete the application 2–3 days prior to the deadline
- 4) The university entrusts the application process to an agency, and collected information(name, resident’s registration number, phone number, e–mail address, academic information, etc.) will not be used for purposes other than admission screening

However, personal information of successful candidates will be used for creating academic records at the university, so it is required to agree to “Collection and Use of Personal Information” and “Academic Inquiry” during application
- 5) All documents must be submitted in PDF format as a single file, in the order of the number of the required documents, and they must be uploaded by the last day of application (file must not exceed 10MB)
 - ※ File Name(example): Ph.D. Course Department of Investigation Kim Daehan
- 6) If the required documents are not uploaded during the application period, the applicant will be excluded from the application process and be disqualified from phase 1 of the document screening

B. Announcement of Screening Results: Wednesday, July 15, 2020, 10:00 (scheduled)

- 1) On Wednesday, July 15, 10:00(scheduled), screening results will be posted on the Korean National Police University website (<http://www.police.ac.kr>) and the application agency website, Jinhaksa (<http://www.jinhakapply.com>)
※ Announcement date may change according to circumstances, and a separate notification will be made if there is a change(no individual notifications will be made)
- 2) Information on the detailed schedule of the interview including the date, time and method will be announced as an announcement of document screening results is made

C. Interview: Monday, July 20, 2020 ~ Friday, July 24, 2020

- 1) An online video interview will be conducted. A phone interview may be employed according to the application status and university circumstance
- 2) Detailed information on the interview method will be notified when document screening results are announced

D. Announcement of successful candidates(scheduled for July 31, 2020, 17:00) and Registration (August 2020)

- 1) On Friday, July 31, 10:00, final admission results will be posted on the Korean National Police University website (<http://www.police.ac.kr>) and the application agency website, Jinhaksa (<http://www.jinhakapply.com>)
※ The announcement date may change according to circumstances, and a separate notification will be made if there is a change(no individual notifications will be made)
- 2) Successful candidates must adhere to “Instructions for Successful Candidates” along with the final announcement, and failing to comply with the instructions may lead to disadvantages
- 3) Admission will be cancelled upon failure to register during the registration period

06 How to Prepare and Submit Required Documents

● Required Documents for eligibility

- **(Foreigners with foreign parents)** Proof of citizenship, proof of relationship between applicant and parents
 - Citizenship Certificate: Submit a copy of valid passport, an original copy of the proof of citizenship or notarization(for a Chinese applicant, submit documents issued by the Notarization Office after July 1, 2019)
 - ※ Chinese census certificates, Chinese IDs and foreign IDs without notarization are not recognized as proof of citizenship
 - If the applicant or his/her parents was/were Korean, he/she must submit proof verifying the date of forfeiture/loss of Korean citizenship and the date of acquiring foreign citizenship
 - The location of the university that the applicant graduated from is irrelevant(foreign nationals who graduated from Korean universities may apply)
 - ※ Academic records such as general equivalency diploma, home schooling and online learning are not accepted as qualifications
- **(Applicants with full educational background outside of Korea)** Proof of entry to and departure from Korea
 - Korean citizens can obtain the document from the immigration office, foreign affairs office, district offices of Seoul, community centers, and overseas diplomatic offices of Korea. The document can also be obtained online from the civil service portal of the Korean government, “Minwon24”(www.gov.kr). Foreign nationals cannot obtain the document from overseas diplomatic offices of Republic of Korea
 - ※ If the above document cannot be obtained, the applicant must submit documents verifying his/her full education outside of Republic of Korea(official documents verifying the enrollment and periods of elementary/middle/high schools and university)
 - All immigration records(entry/departure) to Republic of Korea for all citizenships of the applicant must be recorded from his or her date of birth to April 30, 2020. If any information is missing or immigration status to Korea cannot be verified, the applicant will not be qualified for application
 - ※ If any records are missing, the record must be corrected and obtained through the immigration office, foreign affairs or overseas diplomatic offices of Republic of Korea, and documents verifying the missing information on immigration status must be submitted
 - ※ Even if the applicant moved overseas after his/her birth in Republic of Korea, the applicant must submit an immigration record(entry/departure) from his/her date of birth

- If the applicant changed his/her citizenship due to immigration or adoption, all documents verifying the immigration(entry/departure) information of all citizenships before and after the change of citizenship must be submitted(applicant's date of birth ~ April 30, 2020)
- The applicant's passport number of the current passport and the passport number on the immigration status report must be identical. If the passport number is different because the applicant was issued a new passport, proof of passport issuance or copy/copies of the previous passport/passports and current passport must be submitted
- If the submitted immigration record does not match the actual immigration record(inconsistency between the applicant's academic records and departure, entry and duration of stay, etc.), the applicant must submit statements and related documents(official documents indicating the academic enrollment period in elementary/middle/high schools and university)
- If immigration(entry/departure) records during the period of the departure, when the applicant was accompanied by parents, are not indicated in submitted documents and cannot be corrected, the applicants need to submit a copy of the information on companions recorded on parents' passports

● **Required/additional documents: must be in Korean or English**

- ◉ **(Cover Letter)** Indicate experience, reason for application, future plan, personality, etc
- ◉ **(Transcript)** Upload all transcripts from the university(including a graduate school) that the applicant graduated from, as well as a "perfect score standard of GPA" from the university. If documents are not in Korean or English, translate them and have them notarized
 - ※ Applicants applying for Ph.D. programs must also submit the transcripts of their Master's programs
- ◉ **(Research Plan)** If applying for a master's or Ph.D. program, write a research plan clearly, which describes the applicant's field of research(interest), purpose of research(motivation), research methods and implementation plan, and research performance
- ◉ **(Academic Advisor's Recommendation)** Reasons for recommendation, his/her position and contact information must be included
 - ※ If it is difficult to obtain a recommendation letter from a professor of the university that the applicant attended, it can be replaced with a recommendation letter from a professor from a different university or a superior who knows the applicant's study and academic capability
- ◉ **(Korean Diplomat's Recommendation)** Reason for recommendation, his/her relationship with the applicant and contact information must be included
- ◉ **(Thesis)** Only those applying to the Ph.D program should submit a thesis. If the thesis is not in Korean or English, translate it and have it notarized

- ◊ **(Bank Statement)** Applicant's or parent's certificate of account balance should be scanned and uploaded(issued within 3 months)
- ◊ **(Documents Such as Department/Major-related Certificates)** Only documents related to the department the applicant applies to should be submitted. If the documents are not in Korean or English, translate them and have them notarized
 - ※ Download the form "My Applications" of the application agency website (<http://jinhakapply.com>) and fill it out(cover letter, research plan, recommendation letter)

● Documents Verifying Language Skills

- ◊ Scan the following documents verifying the applicant's language skills and submit them online
